#### Performance Drivers: Organic Loan Growth In Billions




Loan balances shown without mortgages, leasing and acquired portfolios



#### Performance Drivers: DDA Deposit Growth


**Average Balances In Millions**



#### Peer Group Relative Average Ranking Year Ended December 31, 2013







#### Annualized Total Shareholder Return One Year | For the Period From 12/31/2012 to 12/31/2013






#### Annualized Total Shareholder Return Five Years | For the Period From 12/31/2008 to 12/31/2013


#### Annualized Total Shareholder Return Ten Years | For the Period From 12/31/2003 to 12/31/2013
